ADDENDUM No. 6

To all prospective Proposers:

This Addendum No. 6 includes the following information:

- 1. This Addendum addresses a change to the RFP section 2. c. Bus Stops – Paragraph 2:**
While the Proposer will be responsible for snow removal at the bus stops without a bus shelter or bus bench, that are located on the right-of-way, not those on private property, snow removal at those stops is not part of the cost proposal. A snow removal allowance will be set by the County as part of the contractual process.
- 2. This Addendum states that costs for the Rockville Centre facility, or any planned electric infrastructure should not be factored in the cost proposal. The County would work with the selected proposer to determine those costs in the future.**
- 3. Start-Up-Costs: Will not be part of the evaluation process, it will be subject to negotiation.**
- 4. Appendix A – Cost Proposal -Proposers can add items to the Start-Up-Costs list, if necessary.**
- 5. This Addendum addresses a change to the RFP section VI) Proposal Submission Instructions.**
