Addendum No. 2

Invitation for Bid (IFB) V-2213

Bathroom Renovation at Mitchel Field

Dear Prospective Bidder:

The purpose of this addendum is to answer questions and/or provide updates to the above referenced Invitation for Bid (IFB). The following answers to questions and/or updates are hereby made part of the IFB and the ensuing contract. All other provisions and requirements as originally set forth in the IFB, except as amended by an addendum, remain in full force and are binding.

Clarification from Addendum No.1

Bidder Question 6: Do we have to install a temporary partition wall to separate the workspace from the occupied spaces? 2 bathrooms are located next to the locker room area. How are you going to work if that area is occupied?

DELETE:

NICE Bus Response: Yes. The occupied space will have to be sectioned off with structural stand-alone walls and plastic barriers to prevent construction dust from entering the occupied areas. We see a point of egress that will be shared by both employees and the construction team, therefore a flagman will have to be assigned by the contractor for safety.

INSERT:

NICE Bus Response: Yes. The occupied space will have to be sectioned off with structural stand-alone walls and plastic barriers to prevent construction dust from entering the occupied areas. We see a point of egress that will be shared by both employees and the construction team, there are no requirements for a flagman to be assigned.

1	Bidder Question:	I was wondering if it was possible to have an opportunity to see the 6 bathrooms that are out to bid. Was unable to make it to the pre-bid walkthrough so if possible that would be great. Thank you so much.
	NICE Bus Response to question 1	NICE Bus advertised and held a second site tour on February 1 st , 2023 at 10am.
2	Bidder Question:	1. Drawing P-051.00 depicts the plumbing demo plan for Rm's 114 and 115. Drawing P-101.00 shows the new piping layouts. Both these drawings show that both the demo and the new work is behind an existing wall. There are no details or sections that indicate how to access the chase or the size of the chase to accommodate the new piping and carriers. Drawing AD-401.00 is missing that information Please provide a drawing which indicates the size and access to the plumbing chase. We have seen in the past that the chase is totally concealed and enclosed on all sides and the only access is to remove the entire masonry wall for the installation of the piping.





		2. Can you please provide a make and model for all plumbing fixtures?
	NICE Bus Response to question 2	1- Plumbing chases are accessible. Refer to highlighted area for access locations to the plumbing chase that services rooms 114 and 115.
		2- Please refer to Accessories and Fixtures schedules on sheets A-401, A-402 and A-403 for this information.
3	Bidder Question:	At the site walkthrough on 2/1/23 we were told that all waste lines would be not getting removed at all locations. Yet all the drawings P-051.00, P-052.00, P-053.00, P-201.00, P-202.00 & P-203.00 clearly show all plumbing waste lines and domestic water lines are getting demolished at all toilet, urinal & sink locations. If they piping is going to be removed as depicted, please provide clarification of the required wall removal to access the plumbing in chases that is not accessible. Can you please provide clarification if they are getting removed and replaced.
	NICE Bus Response to question 3	There is no replacement of risers. Only limited masonry removals at the bathroom site are required to replace carriers and fixtures. Masonry walls shall be repaired as needed.
4	Bidder Question:	If we are MBE, does that qualify us?
•	NICE Bus Response to question 4	NICE Bus strongly encourages Minority Business participation in all of its Projects and we can always utilize MBE/WBE's for our Projects. However – there is a 20% USDOT DBE Goal for the Prime Contractor to meet on this particular Project and so MBE/WBE's 'cannot be used in place of' a Certified DBE firm(s) aligned to appropriate NAIC Codes for the NICE Bus Bathroom Renovation Project V-2213. A Certified USDOT DBE firm must attain the 20% DBE Goal in accordance with 49 CFR Part 26; if you are unable to attain the 20% DBE Goal, you must show written satisfactory and adequate documentation/evidence of your good faith efforts to meet the DBE Goal.
